UGLY CAR CONTEST OFFICIAL CONTEST RULES

IMPORTANT: Please read these Official Contest Rules (the "Agreement"; the "Terms and Conditions") carefully before participating in the Alliance Credit Union ("Alliance") Ugly Car Contest ("Promotion").

This Agreement explains the Terms and Conditions that govern the Promotion. It is your responsibility to ensure that you have read and understand them. By receiving any prize, reward or benefit in connection to the Promotion, you agree to be bound by the respective Terms and Conditions of the Promotion.

Participating in this promotion and the prizes that are offered to members and non-members is at the sole discretion of Alliance, and Alliance has the right to change respective Promotion Terms and Conditions, in whole or in part, or to discontinue the Promotion, at any time with or without notice to its members or non-members.

Eligibility

Each person submitting an entry for the Grand Prize must be 18 years of age or older, have a valid drivers license and must also meet all criteria needed to open an Alliance share account to qualify for participation in the Promotion and to be enrolled in the Promotion. Eligibility for opening a share account requires you to fall under one of these categories: Community eligibility, Company eligibility, Family eligibility or Household eligibility; see our website at alliancecreditunion.org or call 800.232.8669 for details.

For the ongoing contests on the Alliance Credit Union Page on Facebook ("Alliance Page"), winners must provide Alliance Credit Union with their full name and mailing address to claim prize.

The vehicle submitted for entry must: 1) Be in running condition; 2) have a valid license plate attached to the vehicle issued by the Department of Motor Vehicles (DMV); 3) have current registration stickers; 4) be in safe driving condition; 5) be classified as a passenger vehicle; and 6) be able to drive legally on city streets and highways.

The person submitting the vehicle for entry must be the registered owner and be able to show proof of ownership of the vehicle through registration/title issued by the DMV. To establish running condition, the car winning the Grand Prize must be driven to an Alliance financial center for photographing.

Entries for the Grand Prize are available via paper forms found in Alliance financial centers and via access to the Alliance Page on the Facebook website located at www.facebook.com/alliancecu. If any person chooses to use the online Alliance Page entry, for any contest under the Promotion, that person must have internet access and an email address to be eligible to participate in the Promotion. Alliance is not responsible for your inability to connect to the Internet or log into the Facebook website. Use of the Facebook website is subject to all terms governing its use. Entries for the Grand Prize must be submitted online by 11:59pm PDT, in person at one of our financial centers or by mail no later than 8/15/2010. Mailed entries can be sent to Alliance Marketing Department, P.O. Box 18460, San Jose, CA 95158-8460 and must be postmarked no later than 8/14/2010. All Grand Prize entries must include a photo of the "ugly car" [electronic photo if on-line submission] and the contestant's story about the car and why Alliance should help him/her purchase a new car. If any person chooses to use the paper form to enter, that person agrees to have the photo and story they submit uploaded onto the Alliance Page. All content is subject to approval and may be altered by Alliance if necessary. All entries become the property of Alliance Credit Union and will not be returned.

Members and non-members ("Entrants") must be human beings: no machines, scripts, or automotive services may be used to accumulate prizes, votes or other privileges or benefits associated with the Promotion. Alliance Credit Union cannot anticipate the number of contestants for any prize.

The following individuals are not eligible to win the Grand Prize: 1) Alliance Credit Union employees and immediate families, and official volunteers and immediate families; 2) any person that does not qualify for membership under Alliance's membership criteria (including customer identification requirements); 3) any person who is not a legal adult or lacks the capacity to make contracts; 4) any person who is not a U.S. citizen or lawful permanent U.S. resident. If an ineligible person is selected as the winner, an alternate winner will be chosen and notified by telephone; 5) former Grand Prize winners of an Ugly Car Contest at Alliance. If an ineligible person is selected as the winner, an alternate winner (in descending order of Top 5 vote getters, as eligible) will be chosen and notified by telephone.

Prizes

On 8/17/2010 Alliance Credit Union will choose the "Top 5" ugliest cars from the eligible Entrants and will post those "Top 5" on www.facebook.com/alliancecu. The Grand Prize winner of the Promotion will be determined by the entry, among those "Top 5" that receives the highest number of votes submitted online using the Facebook "Like" feature after 8/17/2010 and before/as of 9/9/2010 at 12:00pm PDT. Each person can vote for a submitted entry/car only once, and the vote must be for one of the "Top 5." Voters must have or create a Facebook account to vote. Votes will be tallied by the "Like" feature on Facebook. The Grand Prize winner will be determined on 9/9/2010 and notified by 9/30/2010. If the Grand Prize winner submitted a paper entry, winner will be notified by phone or by mail if no phone number is provided. If Grand Prize winner entered via Facebook, Alliance Credit Union will message the winner's Facebook account directly.

One winner will receive the Grand Prize of five thousand dollars (\$5,000) that can be used

1. As a credit towards the balance of a new Alliance auto loan; or
2. As a credit towards the balance of an existing Alliance auto loan; or
3. To purchase a vehicle.

If the winner chooses to apply the \$5,000 towards the balance of an Alliance auto loan:

1. A complete loan application must be submitted to Alliance's Loan Department and approved by 10/30/2010 for a new loan.
2. The \$5,000 will be deducted from the funded loan balance no later than 12/31/2010 for both a new and existing loans.

The reduction in loan balance does not affect the due date or the amount of the first or subsequent loan payments. You will be notified by the Credit Union if your payment amount changes. Otherwise, continue to make your payments as agreed per the loan application paperwork. Alliance cannot anticipate the exact amount of the finance charges for the car loan obtained.

1. If the winner chooses to use the \$5,000 towards the purchase of a vehicle, the \$5,000 will be credited to the member's account at Alliance by 12/31/2010.

2. If the member lives in the California Bay Area or the Wilmington, North Carolina Area, he/she will be required to participate in a check-presentation ceremony for PR purposes. Ceremony will be scheduled at member's and Credit Union's mutual convenience.

If the Grand Prize winner is not a member of Alliance Credit Union, he/she must be eligible to join Alliance Credit Union and is required to become a member. Alliance will waive the \$10 one-time membership fee and deposit the \$25 minimum balance into the member share account prior to awarding the prize.

Ongoing prizes: Contests may be held on the Alliance Page on Facebook.com throughout the length of the promotion. All visitors to the site may enter. You must have or create a Facebook account to enter and submit entry online using the Facebook "Wall" feature. The first entrant who solves the puzzle or correctly answers the question(s) will be awarded a prize that will be announced for that particular contest on the site. Prize is valued at \$25 or less. The award will be made that same day and the winner will be notified by Alliance Credit Union through the message feature on Facebook. The prize will be mailed to the winner within the next business day of winner's response providing name and address.

Taxes on the prizes, if any, are the winner's sole responsibility.

By entering the contest and accepting the Grand Prize the winner consents to the use of his/her name and likeness, and of a photo of the winning car in credit union promotional materials in any media.

For the name of the Grand Prize winner, and of ongoing contest small prize winners, send a self-addressed stamped business sized envelope by 10/31/2010 to Alliance Credit Union at PO Box 18460, San Jose, CA 95158.
